

### Introductory note

#### This introductory note does not form a part of the notice

The following notice gives notice of the variation of an environmental permit.

The variation is to increase the annual throughput from 125,000 tonnes to 175,000 tonnes per annum (110,000 tonnes will be inert wastes). This does not require any operational changes to the permit. The total annual storage limit for the site remains the same.

The Operator is experiencing a higher demand to accept inert wastes from local utility companies. This variation to increase the throughput of the site will allow a greater amount of waste to be accepted at the site, which will allow the utility companies to deposit waste at the facility and then collect recycled aggregates for use in construction works in one journey.

The schedules specify the changes made to the original permit.
